## REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF SOCIETY OF RADIOGRAPHERS OF SOUTH AFRICA

10 February 2006

We have audited the annual financial statements of Society of Radiographers of South Africa, set out on pages 2 to 10 for the year ended 31<sup>st</sup> December 2004. These financial statements are the responsibility of the council. Our responsibility is to express an opinion on these financial statements based on our audit.

<u>Scope</u> - We conducted our audit in accordance with statements of South African Auditing Standards. Those standards require that we plan and perform the audit to obtain reasonable assurance that the financial statements are free of material misstatement. An audit includes;

- examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements;
- assessing the accounting principles used and significant estimates made by management, and
- evaluating the overall financial statement presentation.
- We believe that our audit provides a reasonable basis for our opinion.

<u>Qualification</u> - Subscription income is based largely upon unaudited returns received from provincial societies. In common with similar organisations, it is not feasible for the society to institute accounting controls over cash collections from donations prior to the initial entry of the collections in the accounting records. Accordingly, it was impracticable for us to extend our examination beyond the receipts actually recorded.

<u>Qualified Audit opinion</u> - Except for the effects of any adjustments which might have been necessary had it been possible for us to extend our examination of cash collections from donations, and to audit the returns from provincial societies, in our opinion, the financial statements fairly present, in all material respects, the financial position of the society at 31<sup>st</sup> December 2004 and the results of its operations for the year then ended in accordance with generally accepted accounting practice, and in the manner required by the society.

A radiographer will be treated as any other delegate and attendance is not limited to only the ISRRT tract.

The ISRRT tract will handle primarily radiographic issues that are not necessarily academic presentations as per the attached provisional program. The other 8 tracts are broken down into the different systems, for example, musculo-skeletal, abdomen etc, where specialists in the various fields will present papers on each system.
