Reserved rights

All proprietary rights, other than copyright, are reserved to the authors, as well as the right to reproduce original figures and tables from this item in their future works, provided full credit is given to the original publication in The South African Radiographer (SAR).

Originality

The author/s warrant that this submission is an original work and neither this work nor one with substantially similar content has been published elsewhere or in part [except in abstract form] and that it has only been submitted to this publication and will not be submitted elsewhere pending notice of acceptance or rejection by this journal.

Withdrawal of a manuscript by author/s
